PILLAR 1

Foundations

Self-awareness, values and relationship-readiness. Identity, emotional vocabulary, friendship vs romance, confidence through strengths.

PILLAR 2

Etiquette & Communication

Starting and keeping conversations, reading social cues, respectful online profiles, moving between online and in-person connection, handling rejection.

PILLAR 3

Safety & Boundaries

Enthusiastic consent, red flags (coercive control, grooming, financial exploitation), boundaries, online privacy, romance scams, help-seeking.

PILLAR 4

Sexual Health & Intimacy

Delivered by qualified sexologists. Anatomy, sexuality and gender, contraception and STI prevention, healthy vs unhealthy sexual relationships, support pathways.

Built on five evidence bases

Dignity of Risk (Perske) · Supported Decision-Making (UN CRPD Art. 12) · Trauma-Informed Practice (SAMHSA) · Social Learning Theory (Bandura) · Affirmative Sexuality Education (WHO; FPA standards).
